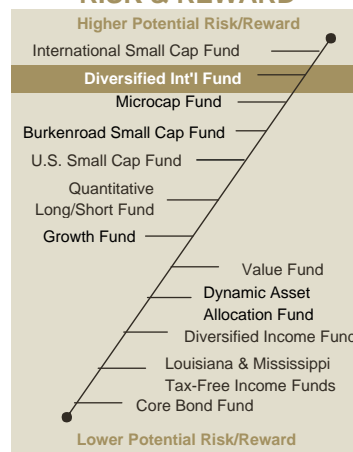

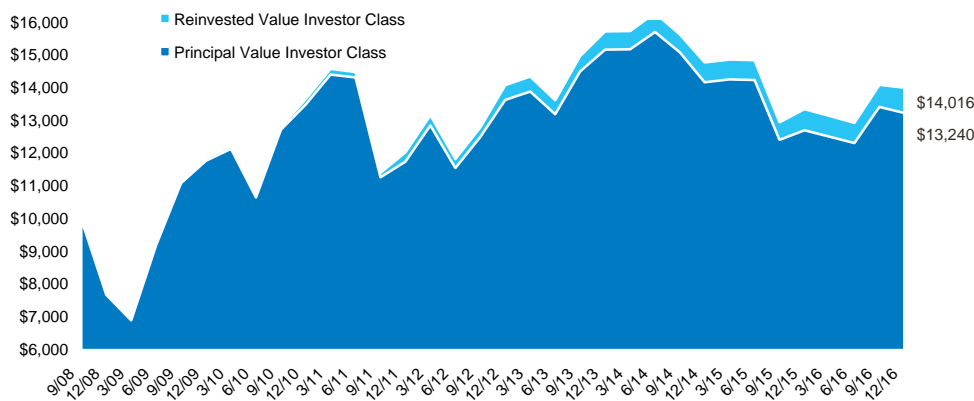
FUND OBJECTIVE
