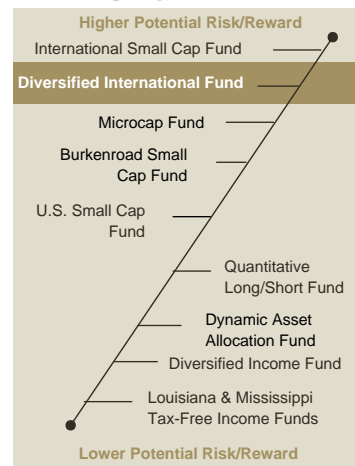

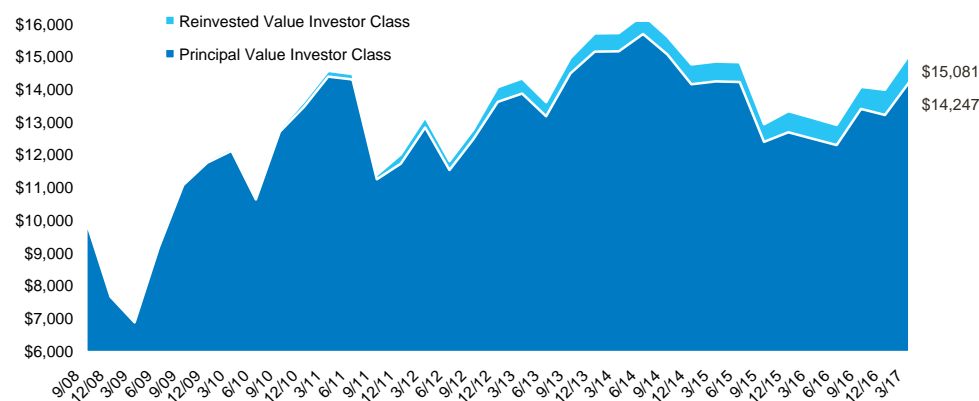
FUND OBJECTIVE
