International small caps are an often overlooked investment opportunity. Their historical long-term performance, diversification and uncorrelated returns make them a key consideration for part of a fully realized global portfolio. Additionally, though the international small cap space is broad, with over 6,000 stocks included in the S&P Developed Ex-U.S. Small Cap Index, there is little coverage of these stocks by Wall Street, which can lead to inefficiencies. Active management, such as that provided in the Hancock Horizon International Small Cap Fund, can take advantage of these inefficient markets with mispriced securities and undiscovered companies.

WHY THE HANCOCK HORIZON INTERNATIONAL SMALL CAP FUND?

The Fund invests in small non-U.S. companies that have market caps predominantly between \$75 million and \$5 billion. We utilize a fundamental, bottom-up process that seeks to identify companies with strong growth prospects not recognized by the market. The Fund is sub-advised by GlobeFlex for additional oversight, international research and analysis. Based in San Diego, GlobeFlex has more than 21 years of experience with a proven research-based approach.

OUR PROCESS

The universe of stocks is ranked from most fundamentally attractive to least, according to:



Our investment team then confirms the fundamentals of each buy/sell decision, reaching consensus on the appropriate course of action by:

- Utilizing leading analysts to identify revenue, operating earnings and cash flow acceleration coupled with rising earnings expectations
- Evaluating the strength of balance sheets, cash flow and operating performance based on economic margin methodology
- Analyzing earnings, revenue and cash flow while adjusting for business cycle, industry and sector where relevant
